

Contest Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

a. Eligibility

The GTrans “Line 1X Contest” (the Contest) is open to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of GTrans, the City of Gardena, Pulsar Advertising and other companies associated with the promotion of the Contest, and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Contest is subject to federal, state, and local laws and regulations.

b. Sponsor

The Contest is sponsored by City of Gardena’s GTrans (the Sponsor), which is located at 13999 S. Western Avenue, Gardena, CA 90249.

c. Agreement to Official Rules

Participation in the Contest constitutes Entrant’s full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon being compliant with these Official Rules and fulfilling all other requirements set forth herein.

d. Contest Period

The Contest begins on Monday, July 18, 2016 at 12:01 AM Pacific Daylight Saving Time and ends on Monday, August 15, 2016 at 11:59 PM Pacific Standard Time (the Contest Period). Entries that are submitted before or after the Contest Period will be disqualified. Submissions will be accepted for the duration of the Contest via mail-in entry form, or the Contest Entry Form at rideGTrans.com.

e. How to Enter

To successfully enter the Contest, Entrants must complete all of the following steps within the Contest Period:

- a. Visit the Line 1X Contest page on the GTrans website, located at RideGTrans.com/freerides.
- b. Fill out all required fields of the Line 1X Contest Entry Form on that web page.
- c. Submit the entry by clicking or tapping the “Enter” button at the bottom of the Entry Form.

OR:

- a. Fill out all required fields of the printed Line 1X Contest Entry Form that was sent to area residents via direct mail.
- b. Submit the entry by mailing the completed form to GTrans Free Rides, City of Gardena, 13999 S. Western Avenue, Gardena, CA 90249.

Limit one (1) entry per person, per email address, and per household for the duration of the Contest Period. Entries received from any person, e-mail address, or household in

excess of the stated limitation will be void. All entries become the property of Sponsor and will not be acknowledged or returned.

f. Prize Drawing

On or about August 15, 2016, the Sponsor will select potential winners in a random drawing from among all eligible entries received. The odds of being selected depend on the number of entries received.

g. Winner Notification

The Sponsor will attempt to notify each potential winner via email, phone or mail on or about August 15, 2016. If the potential winner cannot be contacted or does not respond within seven (7) days after the date of the first attempt to contact him/her, or if the prize is returned as undeliverable, the potential winner forfeits the prize, and the Sponsor may select an alternate potential winner in his/her place at random from the remaining non-winning, eligible entries. Potential winners must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. In the event that a potential winner is disqualified for any reason, Sponsor will award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. Prizes will be fulfilled approximately two (2) weeks after the conclusion of the Contest and after the winner has provided all details needed for delivery of the prize.

h. Prizes

The Sponsor will award the following prizes to potential winners of the Contest:

1st Prize – One (1) winner: One (1) TAP Card preloaded with a monthly GTrans transit pass good for unlimited rides on GTrans. The pass will automatically renew each month for a total of twelve (12) months of free rides, provided the winner uses the pass to ride a GTrans bus at least one (1) time per month.

2nd Prize – Two (2) winners. One (1) TAP Card preloaded with thirty (30) free rides on GTrans.

3rd Prize – Gift cards to local businesses.

i. General Conditions

In the event that the operation, security, or administration of the Contest is impaired in any way for any reason, including, but not limited to fraud, virus, bug, worm, unauthorized human intervention or other technical problem, or in the event the Contest is unable to run as planned for any other reason as determined by Sponsor, the Sponsor may, in its sole discretion, either (a) suspend the Contest to address the impairment and then resume the Contest in a manner that best conforms to the spirit of these Official Rules or (b) terminate the Contest and, in the event of termination, award the prizes at random from among the eligible entries received up to the time of the impairment.

The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Contest may be a

violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages (including attorneys fees) and any other remedies from any such person to the fullest extent permitted by law. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision.

Entrance into the Contest constitutes consent by the Entrant to allow the Sponsor to use, publish, and reproduce for all purposes, including publicity, promotion and advertising, in any media (including online and offline), the Entrant's name, city, photograph, likeness and any other information available directly as a result of entering the Contest in entirety without compensation, credit or right of review or approval.

j. Release and Limitations of Liability

By participating in the Contest, entrants agree to release and hold harmless the Sponsor, and each of their respective parents, subsidiaries, affiliates, advertising and promotion agencies, other companies associated with the Contest, and each of their respective officers, directors, employees, members, representatives, and agents (the Released Parties) from and against any claim or cause of action arising out of participation in the Contest or receipt or use of the prize (including any travel or activity related thereto), including, but not limited to: (a) any technical errors associated with the Contest, including lost, interrupted or unavailable internet connection, network, server, wireless service provider, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone, cellular tower or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties; (b) unauthorized human intervention in the Contest; (c) mechanical, network, electronic, computer, human, printing or typographical errors; (d) application downloads, (e) any other errors or problems in connection with the Contest, including, without limitation, errors that may occur in the administration of the Contest, the announcement of the winner, the cancellation of the Contest, the incorrect downloading or use of required applications, the processing of entries, or errors in any Contest-related materials; or (f) injury, death, losses or damages of any kind to persons or property which may be caused, directly or indirectly, in whole or in part, from entrants' participation in the Contest or acceptance, receipt or misuse of the prize. Entrant further agrees that in any cause of action, the Released Parties' liability will be limited to the cost of entering and participating in the Contest, and in no event shall the entrant be entitled to receive attorney's fees. Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by site users, tampering, hacking, or by any equipment or programming associated with or utilized in the Contest. Entrant waives the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.

k. Disputes

Except where prohibited, each entrant agrees that any and all disputes, claims and causes of action arising out of, or connected with, the Contest or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in California. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, entrants' rights and obligations, or the rights and obligations of the Sponsor in connection with the

Contest, shall be governed by, and construed in accordance with, the laws of California, without giving effect to any choice of law or conflict of law rules, which would cause the application of the laws of any jurisdiction other than California.
